APPLICATION FOR ADMISSION

WHEN DOES REGISTRATION OPEN?

Get Ready, Set, Grow Academy (G.R.S.G) has an ongoing enrollment program. All interested applicants should contact the administration office for a tour.

INSTRUCTIONS FOR ENROLLMENT

Each of the following items must be completed to enroll your child at Get Ready, Set, Grow Academy.

APPLICATION

Complete, sign, and return both the student application form and student contract and all applicable fees to the Admissions office. Please note both parents must sign the application and the contract.

ENROLLMENT FEE

All first time students (students not currently enrolled) will be required to pay a one-time only enrollment fee of \$600. This fee cannot be applied toward tuition and is **non-transferable and non-refundable**. Currently enrolled students do not have to pay the enrollment fee.

TUITION COMMITMENT FEE

A \$1,200 tuition commitment fee must accompany your completed enrollment application and signed contract. This deposit will secure your child's placement until March 1, 2010. The tuition commitment fee will be credited based upon the payment plan you have elected.

POTTY TRAINING

All students enrolling in the Three's or Four's program MUST be potty trained prior to the start of school or camp.

TEACHER/STUDENT REQUESTS

It is our policy NOT to accept any requests for specific teachers and/or students. We will make every effort to place your child with the teacher that best suits his/her needs. We appreciate your confidence in letting us do what we do best – educating your child.

UNIFORMS

All students are required to wear Get Ready, Set, Grow Academy uniforms. Get Ready, Set, Grow Academy uniforms can be purchased from the Prep Connection. Please contact the Prep Connection at (561) 483-8771 for directions.

SCHOOL SUPPLIES / ACTIVITY FEE

A fee of \$100 is due with your first payment.

PAYMENT PLANS

If a time payment plan is desirable, the following payment plans are available. Please be reminded that all rates are quoted inclusive of a 3% cash discount. If payment is made by credit card the discounted rate is not applicable.

Tuition Payment Plan A

A tuition commitment fee of \$1,200 is to be paid upon registration (\$600.00 will be deducted from the first payment due March 2, 2009 and \$600.00 will be deducted from your last payment due December 1, 2010).

Tuition Payment Plan B

A tuition commitment fee of \$1,200 paid upon registration. Tuition will be paid in 10 payments starting March 1, 2010 – December 1, 2010. A 5% surcharge for interest and processing will be added to tuition. Your \$1,200 tuition commitment fee will be deducted from your final payment.

Tuition Payment Plan C

A tuition commitment fee of \$1,200 paid upon registration. The remaining tuition balance is paid in full and may, under this plan only, be charged to a **Master Card, Visa or American Express**.

GET READY, SET, GROW ACADEMY STUDENT CONTRACT

TERMS

With (my/our) payment of the appropriate enrollment deposit, please enter (my/our) child/ward as a student in Get Ready, Set, Grow Academy (GRSG) for the full school year of 2010 to 2011 subject to general statements, rules, regulations, conditions, traditions, and financial terms contained in the Get Ready, Set, Grow Academy (GRSG), the enrollment application packet, which are acknowledged to be a part hereof including the following with which (I am / we are) familiar.

1. (I / We) understand that students are accepted and enrolled by Get Ready, Set, Grow Academy with the expectation that the student will attend and pay tuition and fees for the entire school year and Get Ready, Set, Grow Academy would suffer financial loss if it were required to refund any tuition or fees because the student withdraws or is dismissed or suspended during the school year.
2. All first-time students (students not currently enrolled) will be required to pay a one-time only enrollment commitment fee of \$600. This fee is not applicable to tuition and is **non-refundable and non-transferable**.
3. A tuition commitment fee of \$1200 and a completed contract will secure your child's placement until March 1, for the upcoming school year 2010-2011. This is to be followed by a timely payment of one of the payment plans included in the packet. The \$1200 tuition commitment fee will be applied toward your tuition based on the payment plan you elect.
4. **All students are enrolled for the entire year unless it is expressly agreed to the contrary.** Should the application be withdrawn before July 1st, prior to entry, (GRSG), as consideration for accepting the student, GRSG will retain the tuition commitment fee and 50% of the total annual tuition. After July 1 (I / we) agree that no reduction of (my / our) obligation to pay the full year's tuition and fees can be otherwise made for absence, voluntary or involuntary withdrawal or expulsion. Students will not be allowed to continue to attend classes unless tuition is paid by stated deadlines. **The school has the right to terminate the attendance of any student for any reasons that are contrary to school policy, including the failure of parents to pay part of or all of their financial obligations for the student's attendance.**
5. (I / We) understand that any payment not made when due will be deemed delinquent after a ten day grace period a 5% surcharge will be added to your payment. Non payment of amount due is considered a violation of the Get Ready, Set, Grow Academy contract. Diplomas will be awarded, transcripts provided, only if accounts are paid in full.
6. (I / We) understand that if Get Ready, Set, Grow Academy directly or indirectly must close due to an Act of God, Natural Disaster, Hurricane, Terrorism, Fire etc. or any other act beyond its control, there will be **no refund, credit, time credit or the like** for any days that Get Ready, Set, Grow Academy must close.
7. (I / We) understand that Get Ready, Set, Grow Academy reserves the right to adopt and amend, from time to time, rules and regulations relating to academic and disciplinary matters, and the student shall comply with these rules and regulations. As such, (I / We) understand that Get Ready, Set, Grow Academy reserves the right to dismiss any student for violation of such rules and regulations or whose account is delinquent.
8. (I / We) understand that Get Ready, Set, Grow Academy shall be entitled to recover any and all costs incurred, including reasonable attorney's fees, in connection with any litigation arising out of this agreement. The student or student's parents or financial guardians do hereby covenant and agree to pay all costs, including reasonable attorney's fees, for enforcement of these provisions.
9. (I / We) further understand that Get Ready, Set, Grow Academy is not responsible for damages to or loss of personal belongings.
10. (I / We) hereby grant Get Ready, Set, Grow Academy, the right to use, publish, videotape, photograph, publish on a website or otherwise use in any medium, that Get Ready, Set, Grow Academy deems appropriate, any likeness, photograph, picture, videotape or description of (my / our) child/ward. (I / We) understand any such use is at the sole discretion of Get Ready, Set, Grow Academy. Further, (I / We) agree to hold Get Ready, Set, Grow Academy harmless, from any liability, claim, demand or judgment related to the use of any such image used in good faith.
11. The use of (my / our) child's/ward's photograph and information in school publications or other periodical including but not limited to website, published articles, photograph, videotape, DVD or any other medium in the sole discretion of Get Ready, Set, Grow Academy is authorized without notification, compensation or fee.
12. (I / We) give (my / our) child(ren) permission to participate in enrichment activities provided by an outside contractor.
13. (I / We) authorize Get Ready, Set, Grow Academy to place (my/our) name(s) including child(ren), address, and telephone number in a directory of students to be used solely for the private use of school families.
14. A positive and constructive relationship between Get Ready, Set, Grow Academy and a student's parent/guardian is essential to the fulfillment of Get Ready, Set, Grow Academy's educational purpose. Thus, Get Ready, Set, Grow Academy reserves the right not to extend the privilege of continued enrollment for that school year or any time thereafter or re-enrollment to a student if Get Ready, Set, Grow Academy reasonably concludes that the actions of a parent(s)/guardian(s) make such a positive and constructive relationship impossible or otherwise seriously interfere with Get Ready, Set, Grow Academy's accomplishment of its educational purpose. Any conduct by a student and/or parent which is in violation of the school policy and which Get Ready, Set, Grow Academy administration considers detrimental to the student or other students of Get Ready, Set, Grow Academy may be deemed adequate cause for dismissal without refund of the tuition as a liquidated damage.
15. If in the opinion of a properly licensed and practicing physician, (my/our) child/ward needs medical or surgical services which require (my/our) authorization or consent before the same can be supplied by the undersigned, (I / we) hereby authorize, appoint, and empower Get Ready, Set, Grow Academy to act as (my / our) agent to furnish on (my / our) behalf such oral or written authorization as may be required, and (I/we) release Get Ready, Set, Grow Academy from any and all liability which might arise from giving such authorization; it being (my/own) desire that (my/our) child/ward be furnished with such medical or surgical services as soon as reasonably possible after the need arises.
16. (I / We) understand that the laws of the State of Florida and the regulations of Get Ready, Set, Grow Academy require all students to have on file before attending the first day of classes specific records (immunization, physical and health).
17. In the event the registered child attends Spring and or Summer Camp at GRSG, all of the terms contained herein are applicable and enforced.
18. This contract shall be governed under the laws of the State of Florida. The venue of any action hereunder shall lie exclusively within the Circuit Court of Palm Beach County, Florida, and the parties hereto consent to personal jurisdiction and expressly waive all rights to trial by jury.
19. The below signature acknowledges my full understanding and agreement to the terms of this contract.
20. (I / We) understand that this Agreement contains the entire agreement of the Parties and supersedes all prior Agreements.
21. (I / We) further understand that once this Student Contract is signed and accepted by all parties, no changes may be made for any reason.
